Yet, in a world too often marked by perceived divisions, there is more work for us all to do. We invite you to join us in celebration of Shanti's legacy of compassion to others-as a Peer Support Volunteer, donor, or as a member of our vibrant community extending a hand to those in need. DOROTHY GRAHAM & THE GRAHAM FAMILY FOUNDATION

DONOR PROFILE



Olga and Dorothy Graham, at Olga's 95th birthday in 2002. Photo courtesy of PAWS Prints Fall 2009 Olga and Victor Graham, Dorothy's parents, loved animals. Recalling her parents as "cat people," Dorothy remembers that the family always had felines around to provide great companionship. More than simply pets, the Graham family cats were true members of the family. From early on, Dorothy learned that pets are fundamental to a person's well-being.

For over a decade, Dorothy Graham has honored the compassionate legacy of her parents through the creation of the Graham Family Foundation. Thanks to Dorothy's connection to the PAWS' mission of preserving the human-animal bond, the Graham Family Foundation has awarded PAWS more than \$175,000 in grants since the foundation's formation in 2005.

Dorothy recalls her mom as a giving person her whole life: first serving as a teacher and tutor to "hardest-to-reach" kids in New York and the Bronx; later, Olga volunteered in nursing homes. It was this foundation of demonstrated selflessness, as well as growing up in a cat-loving home, which cemented for Dorothy the true importance of the human-animal bond for all.

Dorothy inherited Olga's values of giving back and supporting people in need. She became involved in the AIDS movement in the 1980s, helping to bring services to those affected by HIV/AIDS in the East Bay. Dorothy remembers this devastating time as "a period of incredible loss where I was seemingly going to funerals constantly."

Through her work in the HIV/AIDS field, Dorothy first heard about PAWS. She was immediately connected to the PAWS mission and began making small consistent donations. Throughout her life, Dorothy saw first-hand how "important pets are to consoling people" and, as she puts it-not just as animals but "members of the family...fundamental to people's well-being."

After her mom passed away in 2005, Dorothy reflected on the values exemplified by her parents and decided to create a foundation to support organizations like PAWS. In 2007, a cornerstone grant from the Graham Family Foundation provided seed funding for PAWS to establish a program to support seniors. PAWS was one of the very first organizations to receive support from the foundation.

Dorothy sees offering services to seniors as a natural extension of PAWS' original mission of serving people with AIDS. This was the beginning of a significant commitment on behalf of the Graham

Family Foundation to helping all people in need keep their pets fed and healthy-a cause that, as Dorothy states, is "one of the most meaningful interventions you can make in someone's life."

With recent first-ever funding from the City of San Francisco to assist seniors in-need and bolster Care Navigation services, PAWS is now more sustainable than ever.

Dorothy highlights the importance of supporting PAWS' services, such as the provision of vouchers for veterinary care, through her own experience caring for an ailing pet. "I had a very beloved cat, Pepsi, and unfortunately he got very sick with cancer," recalls Dorothy. "He had a very sad experience, and it was very traumatic for me."

Her personal experience underscores why Dorothy is so happy to support PAWS with grants that help cover expenses related to vet care vouchers for clients in need. **"It's important to me to help people keep their pets healthy as long as possible**. When people's pets get sick, having the money to take care of them shouldn't be an additional stressor in their lives," says Dorothy.

Dorothy sees the difference made by her grants and considers them a very meaningful intervention in the lives of people in need. "For not a huge amount of money, a little bit can go a long way."

This is the enduring legacy of Olga and Victor Graham.

ON THE ROAD TO HAPPINESS: HULDA'S STORY

When Hulda first came to Shanti as a client in 2001, she was just beginning to find her voice. She grew up in an environment of violence where she was subject to emotional, mental, and physical abuse and made to feel as though she didn't matter. At an early age, Hulda had accepted that she was alive only to suffer. Connecting with Shanti was the beginning of a healthier, happier life for Hulda.

From the beginning, while Hulda was still struggling to find herself and her worth, Shanti valued and accepted her for who she was. Over time, Hulda realized she was *good enough* even if she did not feel like she had reached her potential. Shanti's acceptance of Hulda helped her find acceptance within herself.

Today, Hulda is connected to Shanti's network of care. She meets with Care Navigators and Peer Support Volunteers. She attends a Shanti support group specifically for women living with HIV, where she has the opportunity to speak about her life with her peers. Through these social gatherings and forms of outreach, Hulda is able to build trusting relationships.

Hulda now shares her story through active participation as a board member and panelist for many organizations in the community, including Quan Yin Healing Arts, Women Organized to Respond to Life-Threatening Diseases (WORLD) Committee, and the Black Health Center of Excellence. Hulda's ability to grow her voice and share her story has helped countless others, and she has empowered herself in the process. Shanti offered Hulda the support and safe space she needed to gain self-confidence and strength. If you meet Hulda for the first time today, there is no sign of the shy person she once was. She is now a bright light, full of life, stories, laughter, and acceptance.

VOLUNTEER SPOTLIGHT: IAN MATTHEWS

Shanti staff talked with an inspiring Peer Support Volunteer, Ian Matthews, about spending sunny Saturdays with Margot Murphy Women's Cancer Program client Ida, their favorite museums around town, and how when it comes to volunteering, sometimes mother knows best!

TELL ME A LITTLE BIT ABOUT YOURSELF.

I was born and raised right here in San Francisco, and have wanted to be a doctor since I was in high school. I attended Hamilton College in upstate New York and am currently applying to medical school.

WHAT KEEPS YOU BUSY HERE IN SAN FRANCISCO?

I currently help out in the emergency room and in palliative care at the California Pacific Medical Center Davies campus. I also tutor inmates at San Quentin every Thursday in reading and math, and work 30 hours a week at the University of California, San Francisco oncology lab.

SO HOW DID YOU COME TO FIND US HERE AT SHANTI?

It was January of 2016, and I was looking for a new, more connected experience here in San Francisco, so I asked my mom for some advice. She had attended the Shanti Peer Support Volunteer training a few years prior and encouraged me to sign up. So I attended the next training and, by March, I was a newly minted Peer Support Volunteer!

TELL ME A LITTLE BIT MORE ABOUT YOUR TIME WITH SHANTI CLIENT, IDA.

I usually see Ida on Saturdays. Every other Saturday we will go to the farmers market in Bernal Heights. We like to find seasonal fruits and vegetables—and we always make a stop at the bread stand. Afterwards, we'll

get brunch at Bernal Star, and every so often I'll bring my dog Alex along, too. For the Saturdays in between, we like to visit Rainbow Grocery to go through their amazing cheese selection. Sometimes we'll go to different museums as well. A month or two ago, we spent the whole day at MOMA [San Francisco Museum of Modern Art]. Ida has a particular fondness for the DeYoung, the Palace of Fine Arts, and the SF MOMA–I like to say that she is culturing me!

ANY FUN FACTS YOU CARE TO SHARE ABOUT YOURSELF?

I have three chinchillas.

HOW DOES BEING A SHANTI VOLUNTEER CONTRIBUTE TO YOUR DAY-TO-DAY LIFE?

There have been so many parts of the city that I would not have visited if I wasn't with Ida and Shanti—and I've lived in this city for the majority of my life! From exploring Bernal Heights to visiting museums and restaurants my repertoire has expanded greatly being with Ida. It's helped get me out and about and see the world!

ON THE FOREFRONT OF CARE AND COMBATING ISOLATION

THE LGBT AGING & ABILITIES SUPPORT NETWORK (LAASN)

Now in operation for nearly a year, Shanti's newest program, LAASN, is already making a difference in the lives of nearly 150 clients.

The problem? As identified by the San Francisco LGBT Aging Policy Task Force, "limited supportive services [are] available to address the emotional, behavioral health, and social isolation challenges of LGBT seniors." Further, there is "not even close to an adequate level [of support] to meet the significant unmet needs of this special population within the larger community of seniors." The solution? Shanti.

Designed to combat the growing isolation among LGBT seniors and adults with disabilities, the LAASN Program is a natural expansion of Shanti's existing programs that respond to the evolving needs of San Franciscans. Over the course of two years, the San Francisco LGBT Aging Policy Task Force identified numerous issues facing this unique population, including a lack of services specifically dedicated to improving emotional and behavioral health and reducing social isolation among LGBT seniors. The Shanti Project was selected by San Francisco's Department of Aging and Adult Services (DAAS) to address this urgent and growing need. With a 43-year knowledge base tackling isolation of those most vulnerable in our community, Shanti is proving the perfect fit to face this issue head-on.

LAASN follows the Shanti model of compassionate care for others. To make entry points for friends and neighbors in need as accessible as possible, Shanti takes on isolation in our community in diverse ways. Clients can be matched with a Peer Support Volunteer, who provides between 2-6 hours of oneon-one emotional and practical support. Clients

"San Francisco has taken the lead in supporting the LGBT senior population. Since 2011, we have researched the challenges of the LGBT senior community. The key finding is that even in San Francisco, the level of stigma impacts resources and exacerbates isolation." – Shireen McSpadden, Executive Director, DAAS of the LAASN Program also have a Care Navigator on staff who helps clients maneuver the often complex path to accessing medical care. Through the DAAS contract, Shanti partners with the Curry Senior Center, an organization based in San Francisco's Tenderloin neighborhood that provides primary medical care, case management, counseling education, and meals to seniors. This partnership enables LAASN clients to access additional programming, rounding out their network of care. From help with everyday tasks like laundry or pet care, to keeping medical appointments and coordinating transit, Shanti is helping to reinforce a safety net

"Sometimes I don't know if I am supporting or if I am being supported-we are equals" - Adrian, Shanti Peer Support Volunteer around isolated LGBT seniors and adults, like one of LAASN's earliest clients, John.

Shanti expects to provide services to at least 190 clients by the end of June 2018. This includes at least 2,350 hours of Care Navigation and 69 Peer Support Volunteers matched with clients for ongoing support. This work will enable more members in our vibrant community to face less isolation, better maintain their health, and walk the path of life with a network of compassionate champions by their side.


